



# Booking agreement abroad for a SVERAK-registered cat

It is the responsibility of the vendor that the cat is at least 12 weeks of age and is fully vaccinated against Panleucopaenia and cat flu; that a health declaration issued by a veterinarian (certificate not older than seven days) is handed over to the new owner; and that the cat is identitymarked. It is the responsibility of the vendor that a confirmed transfer declaration is issued by SVERAK and that the cat's SVERAK-pedigree accompanies the cat. Any agreements or limitations must be in writing.

The primary responsibility of the vendor is limited to Swedish legislations and regulations and FIFe and SVERAK statutes and rules. It is the responsibility of the buyer to respect national legislation and regulations of the country of receipt when importing the cat.

The main responsibility of the vendor concerns the health and functioning of the cat as a pet. Other information regarding transferred cat (eg detectable fault or defect).

If a defect not specified in this agreement or on the health declaration is discovered before delivery and supported by the vendor and/or a veterinarian, the purchaser may terminate this agreement and receives a full refund of the deposit paid. In case of dispute between the vendor and the buyer whether a fault or defect exists, the vendor pays for veterinary visits.
